Policy of Intellectual Property Rights (IPR)

1. Introduction

2. Objectives

3. Scope

- Trademarks, service marks, and brand identities.
- Trade secrets and know-how.
- Designs, prototypes, and tangible research materials.

4. Ownership

- Intellectual property created by students, faculty, and staff in the course of their duties or using university resources shall be owned by ISBM University.
- In cases where external funding or collaboration agreements are involved, ownership rights shall be determined as per the terms of the agreement.
- Students, faculty, and staff shall be entitled to equitable compensation and recognition for their contributions to intellectual property.

5. Protection

- ISBM University shall take appropriate measures to protect intellectual property rights through patents, copyrights, trademarks, and other forms of legal protection.

6. Commercialization

- ISBM University encourages the commercialization and transfer of intellectual property for societal and economic benefit.

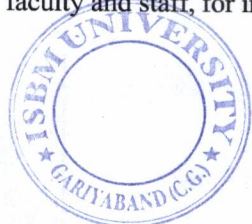
